

2021 Needs Assessment

Triennially, Connecting Communities in Action (CCA) undertakes a comprehensive community needs assessment (CNA) designed to inform the agency, its board of directors and staff, in their decision-making process and the creation and implementation of programming. The results of this CNA are reviewed and analyzed, in order to create the Agency's strategic plan.

The methodology used to undertake the needs assessment process includes the selection of quantitative data from a number of sources, as well as the incorporation of qualitative data garnered through survey instruments and community forums. Specifically, quantitative data is sourced from several resources including but not limited to:

- Community Commons this tool is made available through the New York State Community Action Association (NYSCAA) and is a comprehensive platform of data and visualizations that help to create maps and reports.
- NYSCAA's Annual Poverty Report
- Cattaraugus County Schools
- Cattaraugus County Department of Social Services
- Cattaraugus Allegany County Workforce Development Board
- Cattaraugus County Continuum of Care and Point in Time Data
- Cattaraugus Community Action's internal client data base
- U.S. Census Data

Qualitative Data was gathered via electronic surveys and community forums. For example:

- Agency customers and the community have access to a survey tool designed to capture their most pressing needs via hard copy, CCA's website, or via Facebook
- CCA Board members and employees completed survey tools electronically
- Electronic surveys were widely distributed to collaborative partners, community based and human service organizations, government agencies and elected officials, faith-based organizations, businesses and industry, educational institutions, local coalitions, and more
- Surveys were distributed by way of mobile food pantry
- Input was collected during a staff and partner training event known as a Poverty Simulation
- Surveys were distributed during intake

In some cases, data was collected exclusively for Cattaraugus County, the primary catchment area for Connecting Communities in Action. In other cases (e.g. Nutrition and Housing) data was collected for those counties in which CCA provides programs and services.

Section I: Population Profile – Cattaraugus County, NY

Cattaraugus County has a population of 76,117 in 31,779 households. According to ACS 2015-2019 5-year population estimates for the report area, the female population comprised 50.7% of the report area, while the male population represented 49.3%.

The population is concentrated in the southeast quadrant of the county, with most of the county containing fewer than 51 people per square mile. The county contains a largely white population (91.9%), with a comparatively small number of African American, Native American, Asian and mixed-race residents. Approximately 2.1% of the population is Hispanic. The county population is declining, with numbers from 2010-2019 indicating population estimates for the county decreased by 5.3%.

The American Community Survey (ACS) estimated there were 19,728 families in the report area in 2019. Married couple families comprised 72.84% of the total number. Families headed by men without wives comprised 8.54% of the total, while women without husbands headed 18.62% of families.

Agency customer data: According to the American Community Survey (ACS), 9.90% of the adult population in the report area are veterans, which is more than the national average of 7.29%. Cattaraugus Community Action served 167 veterans during the 2017-2018 and 163 veterans during the 2018-2019 program year.



Section II: Income and Poverty – Cattaraugus County, NY

2019 poverty estimates show a total of 12,711 persons (out of the total population of 74,679) living below the poverty level in Cattaraugus County, or 16.5 % of the County population. Poverty rates vary based on household composition, age and ethnicity. According to the US Census Bureau information in 2019, it is estimated that there were 5,108 households, or 16.1%, living in poverty within the report area. The US National Average of households in poverty in 2019 was 12.9 %. According to 2015-2019 ACS data, of the 19,728 families in Cattaraugus County, NY, 2161 families lived in poverty. Of that number, the number of households in poverty that were comprised of a female householder were 1045, followed by 696 comprised of married couple households in poverty. Of the households in poverty, female headed households represented 48.4% of all households in poverty, compared to 32.2% and 19.4% of households headed by males and married couples, respectively. The percentage of individuals living in poverty: White is 15.03%, Black or African American is 47.89%, Native American or Alaska Native is 37.21%, Asian is 16.23%, Native Hawaiian or Pacific Islander is 0%, Other race is 35.37% and multiple race is 26.94%.

The Community Needs Assessment Survey show that respondents feel that the leading causes of poverty in Cattaraugus County include: 1) Lack of Employment, 2) Alcohol or Drug Usage, 3) Lack of an education, 4) Unwilling or unable to relocate for better resources, 5) Low wages.

The proportion of working-age New Yorkers who were actively in the labor force fell below 60 percent in 2020, to its lowest level since 1984.

In the weeks ending in late February and early March 2020, statewide UI claims averaged around 167,000. Those claims almost doubled to over 314,000, as the shutdown went into effect, climbing upward to a spike that reached more than 3.1 million in mid-May, 2020. https://www.osc.state.ny.us/reports/impact-covid-19-march-4-2021.



Section III: Employment, Cattaraugus County

Cattaraugus County's unemployment rate jumped to 17.5% in April 2020, a strong indicator on how the COVID-19 pandemic has impacted the County's workforce. The unemployment rate nearly tripled from March 2020, however the March surveys were completed before many of the closures were implemented. (https://www.ccbizhelp.com/news/covid-19-pandemic-impact-report-may-29-2020-1271).

In December 2020, the county had an unemployment rate of 6.4%, which was lower than the state averages. Five-year unemployment rates were also slightly lower than state and national rates. The area's average weekly wage is \$822. The current living wage for a single adult is \$11.46/hr. while the living wage for a two adult and two child household is \$19.15 per hour.

Top employers in the area represent government, education, medical, manufacturing and travel and tourism. There are a handful of programs that provide vocational rehabilitation services and job search and training assistance. Service providers include: Olean One Stop Employment Center, Rehabilitation Center and Directions for Independent Living. Additional education and job training resources can be found in Section IV:

Agency data reveals that the majority of agency customers have a High School Diploma/GED or less. Because the link between education and earnings is well documented and agency customers have low incomes (as shown in Section II), data suggests that agency customers have limited access to employment opportunities that offer a living wage.

Community needs assessment survey respondents felt that a lack of employment opportunities was the leading cause of poverty in the area, along with low wages, a lack of job skills, transportation issues and alcohol and/or drug abuse.

Barriers to employment, as identified by survey respondents included a lack of skills/job training, education, childcare, and addictions and/or mental health concerns. Barriers to maintaining employment include lack of transportation, childcare, low wages, few advancement opportunities and fear of loss of benefits. Respondents further identified that existing job/skills training opportunities are unable to meet local needs.

NEEDS STATEMENTS:

Individuals in the community need education and job skills to attain and maintain employment. (Family)

The community lacks sustainable employment opportunities. (Community)



Section IV: Education and Cognitive Development – Cattaraugus County, NY

There are 13 public school districts and three private schools in Cattaraugus County. County wide public-school enrollment during the 2018-2019 school year stood at 12,349 students, with slightly more males than females. Graduation rates were 87.15% for the time school year, which is higher than the state rate of 83.38%.

A total of 58 or 5.73% of enrolled students dropped out of school during the 2018-2019 school year; this percentage is lower than the state average of 6.15%. Drop-out rates are highest in the western portion of the county; the location contains a large Amish population. The same area reflects lower rates of educational attainment that the rest of the county.

Educational attainment rates in the county are somewhat low when compared with the rest of the state.

For the selected area, 10.3% have at least a college bachelor's degree, while 39.2% stopped their formal educational attainment after high school.

The county does offer two higher education opportunities plus vocational training programs. There are also additional services for adults preparing for a HSE certificate and/or those who want to improve literacy levels.

The agency does provide several services related to education and cognitive development. See Section VI: Health, Social/Behavior Development for descriptions of agency services and data supporting this domain.

Finally, community needs assessment survey results show that most respondents do not feel that existing parent support, youth programs and summer recreation programs (all of which can contribute to education and cognitive development) are sufficient to meet local needs.

NEEDS STATEMENT:

Households need parental supports and education to strengthen families and improve education outcomes. (Family)



Section V: Housing – Allegany, Cattaraugus, Livingston, Wyoming Counties

The number of housing units in the four-county service area increased by 2.35% from 2005-2015; while state increases during the same time measured 3.66%. 74.5% of the homes are owner occupied. 50% of the housing stock in the four-county area was build prior to 1960, which suggests that lead based paint concerns are common in the area. According to the US Census Bureau, 1.06% of area housing does not contain plumbing facilities; this is significantly higher that the state average, but the area's Amish population may contribute to the higher percentages.

Fair Market Rents are highest in Livingston county and lowest in Wyoming County. Per the National Low-Income Housing Coalition, housing costs accounted for between 40% and 45% of Median Income in Cattaraugus, Allegany and Livingston counties, while accounting for less than 35.1% in Wyoming County (2016). Overcrowding (more that one person per room) is less of an issue in the four-county area than in NYS or the country. (1.85% vs. NYS 7.22% and US 4.31%)

Numbers of homeless persons in the four-county area are difficult to discern because Allegany and Wyoming counties are part of multi-county Continuums of Care. This agency does not provide homeless services in Allegany, Wyoming or Livingston Counties and so the following information pertains only to Cattaraugus County. In 2016, Cattaraugus County reported 27 homeless persons during its January Point in Time Homeless count. The county does have several resources to prevent homelessness including Emergency Aid to Families (EAF) and Emergency Aid to Adults (EAA) through the local DSS, Solutions to End Homelessness Funding through Cattaraugus Community Action (subcontracted to the Council on Addiction Recovery Services) and rescue funds provided by Emergency Food and Shelter Program (EFSP) and private foundation dollars. The county also had two homeless shelters – Kinley Hill and the Genesis House, as well as Rapid Rehousing assistance.

Community Needs Assessment survey data shows customers and staff/volunteers believe that safe affordable housing is a pressing need in the low-income community. Community members do not feel that existing resources related to housing, shelters/transitional housing, and heating/utility assistance are sufficient to meet local needs.

NEEDS STATEMENT:

Safe and affordable housing is a pressing need within Cattaraugus County.



Section VI: Health and Social/Behavioral Development (including Nutrition)

Health and Health Care – Cattaraugus County

Cattaraugus County ranks among the lowest in the state for health outcomes and health factors. Premature death rates, as well as tobacco use, significantly exceed those for New York State as a whole. The area also has a shortage of physicians. The county has 5.06% of individuals that are uninsured residents. 5.75% of the live births in the county were to teen mothers, which is significantly higher than that state rate of 3.29%. Cattaraugus county ranks in the bottom 25% of the state with respect to teen births and mortality.

Social and Behavioral Development – Cattaraugus County

Like most communities in New York State and the Nation, Cattaraugus County has experienced a rise in opioid use and resulting social consequences. In 2019, opioid death rates rose to 10, in 2018 there were 6 deaths. Newborn drug related diagnoses are somewhat higher, but Cattaraugus County's rates for alcohol-related motor vehicle injuries and binge drinking are significantly higher than those of New York State. While overall crime rates have remained stable, and relatively low, the rates of young adult arrests for property crimes and DUI exceed the New York State average. Child Abuse and Maltreatment rates and foster care admissions are also higher than the State rates.

Nutrition – Allegany, Cattaraugus and Chautauqua Counties

63.94% of the school students in the report area were eligible for free or reduced lunches, compared to a statewide rate of 74.75%. According to Feeding America, Poverty is worse in rural communities than in urban communities. In 2019, 13.3% of all people in rural areas lived below the poverty line compared to 10.0% of people in urban areas. 12.8% of residents in Cattaraugus County had food security rates. Due to the effects of the coronavirus pandemic, more than 42 million people may experience food insecurity, including a potential 13 million children.

The New York Office of Temporary and Disability Assistance reported that 5,802 households in Cattaraugus County received SNAP benefits in 2020, with 10,393 individuals served. In some tracts in the three-county area, over 19.0% of the population receives SNAP assistance.

NEEDS STATEMENT:

Section VII: Civic Engagement – Cattaraugus County

Volunteerism – Cattaraugus County

In 2018, CCCA utilized 541 volunteers, for an average of 33,215 hours of volunteer hours annually. In 2019, CCA utilized 535 volunteers, for an average of 32,968 hours annually. In 2020 CCA utilized 38 volunteers (sudden drop in volunteers was due to Pandemic and legislative actions) for an average of 891 hours annually. Volunteers and hours worked were through agency programming, the board of directors, and the affiliated Food Pantry Network throughout Cattaraugus County.

Current Agency programs reflect a need for volunteer engagement in the areas of fundraising, mentoring, providing transportation, outreach activities, as well as minor office assistance. While throughout the County, it seems that transportation, both for delivery assistance and transportation to medical appointments, is the highest need. Other needs include tutoring, fundraising, mentoring/advocacy, food gleaning and distribution.

NEED STATEMENT:

The agency needs skilled volunteers. (Agency)



Section VIII: Services Supporting Multiple Domains – Cattaraugus County

According to 2019 data provided through the U.S. Census Bureau and https://datausa, 44.6% of households in Cattaraugus County had 2 vehicles, followed by 20.8% having one vehicle and 4.78% having no vehicle. Employees in Cattaraugus County have shorter commute times (20.9 minutes) than the normal U.S. worker (25.3 minutes), and 2.01% of the workforce in Cattaraugus County had "super commutes" longer than 90 minutes.

The most common method of travel for workers in Cattaraugus County was travel by car (82.9%) followed by those who carpooled (8.03%) and lastly walking (4.36%). In 2008, the Community Transportation Coalition of Cattaraugus County was formed and in 2019 developed their latest and most current plan

Limited public transportation options are available; the Olean Area Transportation Service (OATS) is a public transportation service sponsored by the City of Olean for residents of the City and surrounding areas. The Seneca Transit System (STS) is a bus service provided to all area residents. The STS provides transportation between both the Cattaraugus and Allegany territories, with many stops in between. Access Allegany is a public transportation service that operates throughout Allegany and parts of Cattaraugus counties working in relationship with the OATS transportation system. Wyoming Transit Service (WYTS) WYTS is part of the Rochester-Genesee Regional Transportation Authority. Under service agreements with Suburban Adult Services, Inc., WYTS provides transportation for their clients living in Delevan (Cattaraugus County). Taxi and Ridesharing Services are available for parts of Cattaraugus, Wyoming, Chautauqua, and Allegany counties and prices vary depending on location and time of trip. Medicaid travel services are also available for Medicaid recipients.



Population Density








Median Age by Tract, ACS 2015-19



(Adult Ages 18-64)










Foreign-Born Population (Non-Citizen or Naturalized), Percent by Tract, ACS 2015-19




This indicator compares two separate American Community Survey (ACS) 5-year estimates to create a 5-year change in total households.






Population Change



Summary:

2019 poverty estimates show a total of 12,711 persons (out of the total population of 74,679) living below the poverty level in Cattaraugus County, or 16.5 % of the County population. Poverty rates vary based on household composition, age and ethnicity. According to the US Census Bureau information in 2019, it is estimated that there were 5,108 households, or 16.1%, living in poverty within the report area. The US National Average of households in poverty in 2019 was 12.9 %. According to 2015-2019 ACS data, of the 19,728 families in Cattaraugus County, NY, 2161 families lived in poverty. Of that number, the number of households in poverty that were comprised of a female householder were 1045, followed by 696 comprised of married couple households in poverty.

Of the households in poverty, female headed households represented 48.4% of all households in poverty, compared to 32.2% and 19.4% of households headed by males and married couples, respectively.

The percentage of individuals living in poverty: White is 15.03%, Black or African American is 47.89%, Native American or Alaska Native is 37.21%, Asian is 16.23%, Native Hawaiian or Pacific Islander is 0%, Other race is 35.37% and multiple race is 26.94%.

The Community Needs Assessment Survey show that respondents feel that the leading causes of poverty in Cattaraugus County include: 1) Lack of Employment, 2) Alcohol or Drug Usage, 3) Lack of an education, 4) Unwilling or unable to relocate for better resources, 5) Low wages.

The proportion of working-age New Yorkers who were actively in the labor force fell below 60 percent in 2020, to its lowest level since 1984.




























Married Family Households Living Below the Poverty Level, Percent by Tract, ACS 2015-19

Single Parent Family Households Living Below the Poverty Level, Percent by Tract, ACS 2015-19






Population Below the Poverty Level, Children (Age 0-17), Percent by Tract, ACS 2015-19










Children in Poverty by Race Alone, Percent: Age 0 - 17






Child Poverty Rate (ACS) Ages 0-5





Children in Poverty by Race Alone, Total: Age 0 - 5










Poverty Rate Change Age 5-17



2021 Poverty Guidelines

Sec on 673(2) of the Omnibus Budget Reconciliation Act (OBRA) of 1981 (42 U.S.C. 9902(2)) requires the Secretary of the Department of Health and Human Services to update the poverty guidelines at least annually, adjusting them based on the Consumer Price Index for All Urban Consumers (CPI-U). The poverty guidelines are used as an eligibility criterion by the Community Services Block Grant program and many other Federal programs. The poverty guidelines issued here are a simplified version of the poverty thresholds that the Census Bureau uses to prepare its estimates of the number of individuals and families in poverty.

As required by law, this update is accomplished by increasing the latest published Census Bureau poverty thresholds by the relevant percentage change in the Consumer Price Index for All Urban Consumers (CPI-U).

The poverty guidelines are not derived from the Census Bureau's new Supplemental Poverty Measure (SPM). The figures represent annual income.

Methodology:

The agency needs assessment survey had three versions – community members, partners and board, staff and volunteers. They were distributed in hard copy, via email and were also posted on the agency website. Survey distribution began in October 2020 and remains on-going. At the time of survey result analysis, which occurred in March 2021, the agency received total of 326 completed surveys; 146 were from customers and community members.

Each version contained preliminary questions about the respondent's association with the agency. Thereafter, surveys contained identical questions regarding community needs. Questions asked respondents to identify the five leading causes of poverty in Cattaraugus County, the five most pressing needs of low-income county residents, and perceived barriers to employment. All questions provided a standard list of responses with an "other" option. The agency also requested feedback on which needs it should focus on, assuming that resources were not a concern. The survey for customers and community members asked two additional questions: if respondents had difficult accessing services, and if so, why, plus how well existing services are meeting identified needs.

The following chart summarizes responses received. As shown below, respondents in the "Customer/Community" and "Board, Staff and Volunteer" groups felt that lack of employment opportunities and low wages are a leading cause of poverty. Respondents further felt that existing substance abuse usages also affected poverty rates.

Summary:

Cattaraugus County's unemployment rate jumped to 17.5% in April 2020, a strong indicator on how the COVID-19 pandemic has impacted the County's workforce. The unemployment rate nearly tripled from March 2020, however the March surveys were completed before many of the closures were implemented. (https://www.ccbizhelp.com/news/covid-19-pandemic-impact-report-may-29-2020-1271).

In December 2020, the county had an unemployment rate of 6.4%, which was lower than the state averages. Five-year unemployment rates were also slightly lower than state and national rates. The area's average weekly wage is \$822. The current living wage for a single adult is \$11.46/hr. while the living wage for a two adult and two child household is \$19.15 per hour.

Top employers in the area represent government, education, medical, manufacturing and travel and tourism. There are a handful of programs that provide vocational rehabilitation services and job search and training assistance. Service providers include: Olean One Stop Employment Center, Rehabilitation Center and Directions for Independent Living. Additional education and job training resources can be found in Section IV:

Agency data reveals that the clear majority of agency customers have a High School Diploma/GED or less. Because the link between education and earnings is well documented and agency customers have low incomes (as shown in Section II), data suggests that agency customers have limited access to employment opportunities that offer a living wage.


Community needs assessment survey respondents felt that a lack of employment opportunities was the leading cause of poverty in the area, along with low wages, a lack of job skills, transportation issues and alcohol and/or drug abuse.

Barriers to employment, as identified by survey respondents included a lack of skills/job training, education, childcare, and addictions and/or mental health concerns. Barriers to maintaining employment include lack of transportation, childcare, low wages, few advancement opportunities and fear of loss of benefits. Respondents further identified that existing job/skills training opportunities are unable to meet local needs.

Current Unemployment

Labor force, employment, and unemployment data for each county in the report area is provided in the table below. Overall, the report area experienced an average 6.4% unemployment rate in December 2020.






Thirteen Month Unemployment Rates


Unemployment, Rate by County, BLS 2020 - December





They were distributed in hard copy, via email and were also posted on the agency website. Survey distribution began in October 2020 and remains on-going. At the time of survey result analysis, which occurred in March 2021, the agency received total of 326 completed surveys; 146 were from customers and community members.

Each version contained preliminary questions about the respondent's association with the agency. Thereafter, surveys contained identical questions regarding community needs. Questions asked respondents to identify the five leading causes of poverty in Cattaraugus County, the five most pressing needs of low income county residents, and perceived barriers to employment. All questions provided a standard list of responses with an "other" option. The agency also requested feedback on which needs it should focus on, assuming that resources were not a concern. The survey for customers and community members asked two additional questions: if respondents had difficult accessing services, and if so, why, plus how well existing services are meeting identified needs.

Summary

There are 13 public school districts and three private schools in Cattaraugus County. County wide public-school enrollment during the 2018-2019 school year stood at 12,349 students, with slightly more males than females. Graduation rates were 87.15% for the time school year, which is higher than the state rate of 83.38%.

A total of 58 or 5.73% of enrolled students dropped out of school during the 2018-2019 school year; this percentage is lower than the state average of 6.15%. Drop-out rates are highest in the western portion of the county; the location contains a large Amish population. The same area reflects lower rates of educational attainment that the rest of the county.





Summary:

The number of housing units in the four-county service area increased incrementally and steadily from 2017-2019. 74.5% of the homes are owner occupied. 50% of the housing stock in the four-county area was built prior to 1960, which suggests that lead based paint concerns are common in the area. According to the US Census Bureau, 1.56% of Cattaraugus County, 1.41% of Allegany County and .27% of Livingston & Monroe County housing do not contain plumbing facilities; this is significantly higher that the state average, but the area's Amish population may contribute to the higher percentages.

Fair Market Rents are highest in Livingston County and lowest in Wyoming County. Per the National Low-Income Housing Coalition, housing costs accounted for between 40% and 45% of Median Income in Cattaraugus, Allegany and Livingston counties, while accounting for less than 35.1% in Wyoming County (2016). Overcrowding (more than one person per room) is less of an issue in the four-county area than in NYS or the country.

Numbers of homeless persons in the four-county area are difficult to discern because Allegany and Wyoming counties are part of multi-county Continuums of Care. This agency does not provide homeless services in Allegany, Wyoming or Livingston Counties and so the following information pertains only to Cattaraugus County. In 2020, Cattaraugus County reported 24 homeless persons during its January Point

in Time Homeless count. The county does have several resources to prevent homelessness including Emergency Aid to Families (EAF) and Emergency Aid to Adults (EAA) through the local DSS, Solutions to End Homelessness Funding through Cattaraugus Community Action (subcontracted to the Council on Addiction Recovery Services) and rescue funds provided by Emergency Food and Shelter Program (EFSP) and private foundation dollars. The county also had two homeless shelters – Kinley Hill and the Genesis House, as well as Rapid Rehousing assistance.

Community Needs Assessment survey data shows customers and staff/volunteers believe that safe affordable housing is a pressing need in the low-income community. Community members do not feel that existing resources related to housing, shelters/transitional housing, and heating/utility assistance are sufficient to meet local needs.

Housing Units

The number of housing units within the report area in July of each year from 2010-2019 is shown below. According to the U.S. Census, there were a total of 426,137 housing units in the report area in 2019, an increase of 11,053 (or 2.66%) since 2010 compared to a 3.57% increase statewide.





Hours per Week at Minimum Wage Needed to Afford Housing, 1-Bedroom (at FMR) by County, NLIHC 2020









Overcrowded Housing (Over 1 Person/Room), Percent by Tract, ACS 2015-19









Cattaraugus County Department of Social Services EAF, EAA and HEAP - In 2019, 2822 cases received HEAP in Cattaraugus County, NY.

EAA funds expended Services in 2019, 2020 and 2021 with those EAF/EAA funds including emergency housing, first month's rent, utility payments, non- utility emergencies, heating equipment repairs/replacements and transportation expenses.

Emergency Homeless Assistance

Cattaraugus County Department of Social Services – hotel/motel vouchers, Code Blue Shelter. In 2019 the LDSS sheltered 56 individuals in local hotels/motels for a total of 232 nights. In 2020, the LDSS

sheltered 59 individuals for a total of 173 nights. This is in addition to homeless households served by local homeless shelters.

Genesis House Homeless Shelter, Olean – women and families plus three beds for men. During 2020, this program sheltered 123 individuals.

Saving Grace Ministries- Trading Post, Cattaraugus – two apartments for singles or families.

<u>Legal Assistance –</u>

Legal Assistance of WNY (LAWNY). Free civil representation for tenant/landlord proceedings, mortgage foreclosures, Debtors in chapter 7 bankruptcies if wages are being garnished and debtors in chapter 13's if they are at risk of losing their house to a mortgage or tax foreclosure.

Housing Location –

Cattaraugus County Department of Aging – Assistance for seniors searching for housing that meets needs. Assistance in accessing supportive living or nursing home care. In 2019, the Department took calls from 245 unduplicated individuals seeking housing related assistance. In 2020, the Department took calls from 258 unduplicated individuals.

211 Western New York -

In 2019-2020, 211 WNY received 485 calls requesting information on needs in Cattaraugus County. Housing and utility related assistance requests accounted for (26.4%) and 4.6% of needs identified.

Agency Services in this Domain

Housing

515 Senior and Disabled Housing Sites (5 locations): Provision and management of smoke-free, safe and affordable housing units for low income, elderly, and/or disabled persons of any age. Housing options are at the Delevan, Franklinville, Little Valley, and Randolph Terraces, as well as Willow Brook Manor.

Derby Single Room Occupancy (22 units): Permanent living for single, homeless individuals or those at risk of homelessness. Residents receive extensive case management through CCA's Transitional Services Department.

Jefferson House Apartments (8 units) Permanent housing for homeless persons with documentable disability. Residence in JHA includes the assistance of the Transitional Services Department's case management and skill-building. Apartments are co-located with CCA's program headquarters in Salamanca, New York, to facilitate accessibility of services.

Kinley-Hill Emergency Shelter & Single Room Occupancy (10 units/18 units) Emergency shelter for homeless, single adults. Stays of up to 14 days allow individuals to transition into permanent housing with the assistance of CCA's Transitional Services Department. The SRO provides permanent housing for single, homeless individuals or those at risk of homelessness. Residents receive case management services with the Transitional Services Department, as well.

Weatherization and Housing Rehabilitation:

Weatherization Assistance Program (WAP): Serving low-income, elderly, and disabled homeowners and renters. Energy audits, health and safety measures, energy conservation, education, emergency furnace repairs and replacements, other minor repairs related to energy needs. Serving Allegany, Cattaraugus, Livingston and Wyoming Counties.

Housing Rehabilitation Programs: CCA may serve qualifying owner-occupied homes addressing health and safety issues, bringing the units up to Housing Quality Standards. Services include, but are not limited to: manufactured home replacement, lead hazard reduction, structural corrections, thermal upgrading, mechanical systems, and other health and safety issues.

Homeless Prevention:

EFSP and Private Foundation Funding - Rescue funding is available on a first come, first served basis for households with rental or utility arrearages. Assistance is also available for security deposits if needed to secure safe affordable housing. Payment is limited to one month's arrearages or security deposit equaling one month's rent. Payment must guarantee an additional 30 days of housing or utility service.

Solutions to End Homelessness Program (STEHP) – CCA contracts with the Council on Addiction Recovery Services for the provision of case management-based services to help households remain in their housing or relocate if needed to prevent homelessness. Financial assistance is available for rent/utility arrearages and relocation costs. 30% AMI requirement.

Agency Data:

Part of the agency intake process involves gathering data on housing for all CCA customers. Housing for customers served during this 2016-2017 and 2015-2016 program years is shown below. Note that housing data is shown only for households on whom data is collected. The agency operates several "no questions asked" services; data is not collected on customers accessing those services.

Housing:

During the 2017-2018 CSBG Program year, 169 households applied for safe suitable housing at CCA. 13 seniors attained housing at the 515's, 12 people with disabilities attained housing at the 515's, 1 family moved into JHA apartments. (In addition, 145 maintained safe suitable housing by recertifying/remaining in tenancy at one of the agency's housing projects.

During the 2018-2019 CSBG Program Year, 159 households applied for safe suitable housing at CCA. 8 seniors attained housing at the 515's, 6 people with disabilities attained housing at the 515's, 1 family moved into JHA apartments. (In addition, 145 maintained safe suitable housing by recertifying/remaining in tenancy at one of the agency's housing projects.

Housing Rehabilitation

During the 2017-2018 CSBG Program Year the agency's Weatherization and Housing Rehabilitation Program provided the following services: 446 households inquired about housing rehabilitation and energy conservation services. Of that number, 184 household received emergency conservation services. All households had reduced energy usage as a result. 30 households received housing rehabilitation services. All households had a safer living environment because of improvements to the home.

During the 2018-2019 program year, 433 households inquired about_housing rehabilitation and energy conservation services. Of that number, 209 household received emergency conservation services. All households had reduced energy usage as a result. 30 households received housing rehabilitation services. All households had a safer living environment because of improvements to the home.

Between 1/2018- and 12/2020, the agency received 46 applications for its Cattaraugus County manufactured home replacement initiative. Weatherization staff have replaced manufactured homes in

Allegany and Cattaraugs County. The agency has received 2019 funding for mobile home replacement in Cattaraugus County; this grant will replace an additional five manufactured homes.

Emergency Homeless Shelter –

During the 2017-2018 CSBG Program year, the agency's emergency homeless sheltered temporarily housed 154 homeless single adults, placing 85 in permanent housing.

During the 2018-2019 CSBG Program year, the emergency shelter temporarily housed 156 single adults. 68 were subsequently placed in permanent housing.

Homeless Prevention –

During the 2017-2018 CSBG Program year, 180 households inquired about assistance with utility or rental arrearages or security deposits. The agency assisted 17 households with utility arrearages, 27 households with rental arrearages. All households-maintained housing and utility services for an additional 30 days as a result.

In the 2018-2019 Program year, 151 households inquired about assistance with utility and rental arrearages or security deposits. The agency assisted 20 households with utility arrearages and 2 households with rental arrearages. All households-maintained housing and utility services for an additional 30 days as a result. In addition, 2 households received security deposits to secure safe affordable housing.

<u>During the 2018-2019 CSBG Program year, the STEHP program served a total of 64 households.</u> All persons served by the program were at risk of homelessness because of rental and/or utility arrearages, legal eviction with no resources to relocate, unsafe housing, or tenuous housing situations (staying with family or friends and unable to stay longer) No household served had income exceeding 30%AMI.

Needs Assessment Survey Data Related to this Domain

Methodology:

The agency needs assessment survey had three versions – community members, partners and board, staff and volunteers. They were distributed in hard copy, via email and were also posted on the agency website. Survey distribution began in October 2020 and remains on-going. At the time of survey result analysis, which occurred on March 2021 the agency received total of 326 completed surveys; 146 were from customers and community members.

Each version contained preliminary questions about the respondent's association with the agency. Thereafter, surveys contained identical questions regarding community needs. Questions asked

respondents to identify the five leading causes of poverty in Cattaraugus County, the five most pressing needs of low income county residents, and perceived barriers to employment. All questions provided a standard list of responses with an "other" option. The agency also requested feedback on which needs it should focus on, assuming that resources were not a concern. The survey for customers and community members asked two additional questions: if respondents had difficult accessing services, and if so, why, plus how well existing services are meeting identified needs.

The following chart summarizes responses received. As shown below, respondents in the "Customer/Community" and "Board, Staff and Volunteer" groups felt that safe affordable housing is a pressing need for the low-income population.

Summary

Health and Health Care – Cattaraugus County

Cattaraugus County ranks among the lowest in the state for health outcomes and health factors. Premature death rates, as well as tobacco use, significantly exceed those for New York State as a whole. The area also has a shortage of physicians. The county has 5.06% of individuals that are uninsured residents. 5.75% of the live births in the county were to teen mothers, which is significantly higher than that state rate of 3.29%. Cattaraugus county ranks in the bottom 25% of the state with respect to teen births and mortality.

Social and Behavioral Development – Cattaraugus County

Like most communities in New York State and the Nation, Cattaraugus County has experienced a rise in opioid use and resulting social consequences. In 2019 opioid death rates rose to 10, in 2018 there were 6 deaths. Newborn drug related diagnoses are somewhat higher, but Cattaraugus County's rates for alcohol-related motor vehicle injuries and binge drinking are significantly higher than those of New York State. While overall crime rates have remained stable, and relatively low, the rates of young adult arrests for property crimes and DUI exceed the New York State average. Child Abuse and Maltreatment rates and foster care admissions are also higher than the State rates.

Nutrition - Allegany, Cattaraugus and Chautauqua Counties

63.94% of the school students in the report area were eligible for free or reduced lunches, compared to a statewide rate of 74.75%. According to Feeding America, Poverty is worse in rural communities than in urban communities. In 2019, 13.3% of all people in rural areas lived below the poverty line compared to 10.0% of people in urban areas. 12.8% of residents in Cattaraugus County had food security rates. Due to the effects of the coronavirus pandemic, more than 42 million people may experience food insecurity, including a potential 13 million children.


The New York Office of Temporary and Disability Assistance reported that 5,802 households in Cattaraugus County received SNAP benefits in 2020, with 10,393 individuals served. In some tracts in the three-county area, over 19.0% of the population receives SNAP assistance.




Federally Qualified Health Centers, POS September 2020



Uninsured Population, Percent by County, SAHIE 2018








Agency Services Supporting this Domain

Domestic Violence Residential and Non-Residential Services: Shelter, 24-hour hotline, court accompaniment, legal and medical advocacy, crime victim claims assistance, therapeutic services for victims of domestic violence and their children.

Sexual Assault Assistance: 24-hour hotline, court accompaniment, legal and medical advocacy, crime victim claims assistance, therapeutic services for victims of sexual assault in Allegany and Cattaraugus Counties.

Crime Victim Assistance: 24-hour hotline, court accompaniment, legal and medical advocacy, crime victim claims assistance, therapeutic services for victims of sexual assault in Allegany and Cattaraugus Counties. Specialized services are also available for Native Americans on the Allegany Territory.

Prevention Services: School and community outreach for prevention of partner and other crimes. Enough is Enough prevention services on all college level campuses in Allegany and Cattaraugus Counties.

Families and Schools Together (FAST Program): School based and family-based approach to preventing out-of-home placement of at-risk youth in all school districts throughout Cattaraugus County. Referrals are generated from the Juvenile Needs Task Force.

Attendance Support Program (Truancy Prevention): CCA has partnered with Olean City Schools, Gowanda Central, Cattaraugus-Little Valley Schools, and the Cattaraugus County Department of Social Services to address truancy and tardiness by working with the students, educating parents and guardians, and assisting the school system in establishing Attendance Support Teams and guidelines.

Family Group Conferencing: This program, currently offered by CCA and Parent Education Program, involves a strength-based approach for families planning for the safety and permanency of their child(ren). It enables children to strengthen relationships and vital attachments with family, community, and culture.

CPS Mini Preventative Program: Referrals are received from Child Protective Services throughout the county. The program focuses on a family's strengths, rather than the CPS report. The goals of the program are to prevent the need for future CPS involvement, help families develop neighborhood and community-based supports, and to engage families early, provide support and build family resiliency.

3rd **Party Service Plan Reviews:** Contracted by the Department of Social Services, CCA serves as an independent reviewer/facilitator for child welfare cases where service plans are required to assure the safety, permanency, and well-being of children.

Walking School Bus: Was created through the Attendance Support Program in the Olean City School District. A "Walking School Bus" is a group of children being walked to school by one or more adults. The program is aimed at reducing truancy rates, increasing safety, and promoting healthy lifestyle changes.

Home Visiting Program: An in-home parenting program that provides parenting skills and structure in a one-on-one setting. This program addresses safety and risk in the home and works on identifying family goals.

Parenting Workshop: A seven-week parenting class that uses the Active Parenting model. Parenting skills are taught in classroom/group settings.

Pop-Ins: Assists Cattaraugus County caseworkers in addressing safety issues and concerns in the home setting. Pop-In visits are unannounced visits that occur at various times to ensure needs and goals of the family are being met.

Supervised Visitation: Arranged and set up by Cattaraugus County, whereas non-custodial parents have access to their children in a safe environment. Supervised visits are utilized as a safety measure to ensure that children are safe, while also allowing parents to build relationships with their children. Parenting skills and support are provided to both the parents and the children during the visits.

New Pathways to Responsible Fatherhood Initiative: This initiative is designed to help fathers or those in a father-like role improve their economic stability, develop and maintain healthy relationships, and develop/improve responsible parenting skills. The focus of the group is to promote fatherhood and the importance of being a positive male role model for children.





Family Offenses

The following chart lists the three types of family court intakes managed by the Cattaraugus County Probation Department in 2018. These intakes are either PINS (Persons in Need of Supervision), JD (Juvenile Delinquent) or domestic violence cases in which the victim is typically seeking an Order of Protection from Family Court. PINS cases are based upon incorrigibility, ungovernable behavior, truancy, and use of marijuana (activities not considered a crime if committed by an adult). JD offenses are those activities by a youth that would constitute a crime if committed by an adult.

Effective October 1, 2018, the age of criminal responsibility in NY was raised from 16 to 17. Effective October 1, 2019 this age was raised from 17 to 18, meaning 17 year olds could no longer be treated as adults. Certain young offenders, including those arrested for violent felonies or sex offenses, have been handled in newly-created Court- the Youth Part of Superior Court, and been assigned a new designation, Adolescent Offenders.

Hunger Prevention and Nutrition Assistance Program: CCA secures food resources from food banks, farmers, correctional facilities, grocers and other donors for redistribution among participating food panties and soup kitchens in Cattaraugus County.

Nutrition Outreach and Education Program: Operating in Allegany, Cattaraugus, and Chautauqua Counties, this program provides outreach, education, and application assistance for SNAP (food stamp) benefits and promotes other Federal Feeding Programs.

Summer Food Service Program: Provides nutritious lunches for children 0-18 at playground, school and other public sites during those months when children do not have regular access to free and reduced prices school meals.

Food Pantry and Soup Kitchen: CCA operates one of the county's largest food panties as well as storage and redistribution services for other area pantries. Needs Assessment Survey Data Related to this Domain

Methodology:

The agency needs assessment survey had three versions – community members, partners and board, staff and volunteers. They were distributed in hard copy, via email and were also posted on the agency website. Survey distribution began in October 2020 and remains on-going. At the time of survey result analysis, which occurred in March 2021, the agency received total of 326 completed surveys; 146 were from customers and community members.

Each version contained preliminary questions about the respondent's association with the agency. Thereafter, surveys contained identical questions regarding community needs. Questions asked respondents to identify the five leading causes of poverty in Cattaraugus County, the five most pressing needs of low income county residents, and perceived barriers to employment. All questions provided a standard list of responses with an "other" option. The agency also requested feedback on which needs it should focus on, assuming that resources were not a concern. The survey for customers and community members asked two additional questions: if respondents had difficult accessing services, and if so, why, plus how well existing services are meeting identified needs.

The following chart summarizes responses received. As shown below, respondents in the "Customer/Community" and "Board, Staff and Volunteer" groups felt that substance use disorders are a leading cause of poverty and are a barrier to people finding and maintaining employment. Respondents further felt that existing substance abuse services are unable to meet local needs.

Mental Health issues were also cited as a barrier to employment and a pressing need among the low-income population. These issues were identified only among partnering providers who participated in the survey.

Respondents also felt that dental services are unable to meet local needs.

Summary:

According to 2019 data provided through the U.S. Census Bureau and https://datausa, 44.6% of households in Cattaraugus County had 2 vehicles followed by 20.8% having one vehicle and 4.78% having no vehicle. Employees in Cattaraugus County have shorter commute times (20.9 minutes) than the normal U.S. worker (25.3 minutes), and 2.01% of the workforce in Cattaraugus County had "super commutes" longer than 90 minutes.

The most common method of travel for workers in Cattaraugus County was travel by car (82.9%) followed by those who carpooled (8.03%) and lastly walking (4.36%). In 2008 the Community Transportation Coalition of Cattaraugus County was formed and in 2019 they developed their latest and most current plan


Limited public transportation options are available; the Olean Area Transportation Service (OATS) is a public transportation service sponsored by the City of Olean for residents of the City and surrounding areas. The Seneca Transit System (STS) is a bus service provided to all area residents. The STS provides transportation between both the Cattaraugus and Allegany territories, with many stops in between. Access Allegany is a public transportation service that operates throughout Allegany and parts of

Cattaraugus counties working in relationship with the OATS transportation system. Wyoming Transit Service (WYTS) WYTS is part of the Rochester-Genesee Regional Transportation Authority. Under service agreements with Suburban Adult Services, Inc., WYTS provides transportation for their clients living in Delevan (Cattaraugus County). Taxi and Ridesharing Services are available for parts of Cattaraugus, Wyoming, Chautauqua, and Allegany counties and prices vary depending on location and time of trip. Medicaid travel services are also available for Medicaid recipients.

Commuter Travel Patterns

This table shows the method of transportation workers used to travel to work for the report area. Of the 32,891 workers in the report area, 82.6% drove to work alone while 7.9% carpooled. 0.4% of all workers reported that they used some form of public transportation, while others used some optional means including 4.8% walking or riding bicycles, and 1.0% used taxicabs to travel to work.



STS provides transportation between the Cattaraugus and Irving Reservations with numerous stops enroute. There are transfer stops with the OATS system in two Salamanca locations. STS routes are divided into two zones (North & South), the fare is based on the number of zones you travel through. Zones are shown on schedule maps.

Child Care Services

Types of Child Care

There are many types of child-care to choose from in New York State, although not all are available in Cattaraugus County.

Day Care Centers - provide care for more than six children at a time, not in a personal residence.

Family Day Care Homes - provide care for three to six children at a time in a residence; may add one or two school-age children. The maximum allowable number of children will depend on whether there are and how many infants are in care.

Group Family Day Care Homes - provide care for seven to twelve children at a time in a residence; may add one or two school-age children. The maximum allowable number of children will depend on whether there are and how many infants are in care. A provider must use an assistant when more than six children are present.

*Each of the programs listed above can serve children ages six weeks through twelve years and operate for more than three hours a day.

School-Age Child Care Programs - provide care for more than six children from kindergarten through age twelve. Care for children during non-school hours; also, may provide care during school vacation periods and holidays.

Other forms of legal child care include:

Nursery Schools - provide care for three hours a day or less. In New York City, the City Department of Health regulates these programs. A nursery school may voluntarily register with the State Education Department (SED).

Pre-Kindergartens - usually located in public schools, but can also be found in private schools or day care centers; supervised by the SED.

Head Start Centers - targeted for preschool-age children from low income families; federally funded and usually licensed as Day Care Centers.

Non-regulated/Informal Care – is home-based care for one to two children at a time in addition to the provider's children; are not required to register.

Department of Social Services Day Care Subsidy Program:

Funded by the New York State Child Care Block Grant. This program provides child-care subsidies to families with incomes below 200% of the federal poverty level. Eligibility for subsidy is based on the parents'/guardians' participation in at least one of the following:

- Educational and training programs that lead to employment in a demand occupation. The list of demand occupations is generated by the state Department of Labor.
- Working parents
- Teenage parents who were completing their high school education.
- Families who needed help to prevent a child's out-of-home placement.
- Working parents who are transitioning from Temporary Assistance
- Day care for Foster Parents to ensure day care while working.

Not all child care providers participate in the Day Care Subsidy Program.

Needs Assessment Survey Data Related to this Domain

Methodology:

The agency needs assessment survey had three versions – community members, partners and board, staff and volunteers. They were distributed in hard copy, via email and were also posted on the agency website. Survey distribution began in October 2020 and remains on-going. At the time of survey result analysis, which occurred in March 2021, the agency received total of 326 completed surveys; 146 were from customers and community members.

Each version contained preliminary questions about the respondent's association with the agency. Thereafter, surveys contained identical questions regarding community needs. Questions asked respondents to identify the five leading causes of poverty in Cattaraugus County, the five most pressing needs of low-income county residents, and perceived barriers to employment. All questions provided a standard list of responses with an "other" option. The agency also requested feedback on which needs it should focus on, assuming that resources were not a concern. The survey for customers and community members asked two additional questions: if respondents had difficulty accessing services, and if so, why, plus how well existing services are meeting identified needs.

The following chart summarizes responses received. As shown below, all survey groups felt that a lack of employment opportunities is a leading cause of poverty. Transportation and childcare are also seen as two of the most pressing needs of households with low income. Both lack of transportation and lack of childcare are also seen as barriers to obtaining and maintain employment. Finally, customers/community members felt that transportation services were the least likely to meet local needs.
